PARKING PERMIT INFORMATION

Attached is your **2008 PARKING PERMIT** to use **MAY 1 THROUGH OCTOBER 1.**

This permit will allow you to park in all areas posted "Parking By Permit Only."
It **DOES NOT** allow you to park in "No Parking" areas.

LICENSE PLATE NUMBER(S)

You must have the correct license plate number for each vehicle for which you are obtaining a permit.

For example, if you need two additional permits, you must provide three license numbers – which includes the license plate # you used for the first permit mailed to you.

Registration checks will be made on all applications for additional permits, and persons whose vehicles are not registered to them will be required to provide proof of ownership.

RENTERS

Parking permits are mailed to property owners only, with no attempt to reach tenants.

If you have a tenant, they must apply for a permit at City Hall with two forms of ID showing that they reside in Deephaven.

IT IS ILLEGAL TO SELL, ASSIGN OR OTHERWISE TRANSFER A PERMIT. (Ord. #450).

Vehicles parked in permit zones are randomly checked by the police to ensure that the registration of the vehicle license number matches with the parking permit number on the car. If the permit is displayed on a vehicle which is registered to someone other than to whom the permit was issued, the vehicle is subject to a TAG AND TOW.

PERMIT PLACEMENT

ALL EXPIRED PERMITS MUST BE REMOVED.

Peel the permit from the backing paper and place it on the **OUTSIDE** of the window on the **DRIVER'S SIDE OF THE VEHICLE AS FAR TO THE REAR AS POSSIBLE** (i.e., back seat SIDE window)
