Fireworks update

The Excelsior Fire District Firefighters want you and your family to be safe on the 4th of July and anytime you choose to use fireworks. It is important for all citizens to understand the new fireworks laws and be well informed of safety precautions when using legal fireworks. Sales, possession and use of SOME non-explosive and non-aerial consumer fireworks are now permitted in Minnesota. These fireworks MAY NOT be used on public property such as city owned docks, beaches, parks, trails, bridges, parking lots, schools, etc.

Examples of legal fireworks include sparklers, cones, tubes that emit sparks, novelty items like snakes and party poppers. You must be 18 years old with photo identification to purchase fireworks.

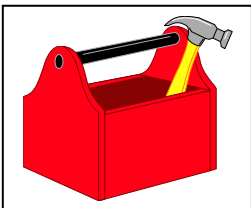
The Fire District suggests the following safety guidelines:

- 1) Use fireworks with close adult supervision.
- 2) Read and understand the directions.
- 3) Keep fireworks away from Children. (sparklers alone burn at nearly 1200° F)
- 4) Never place any part of your body over a firework device.
- 5) NEVER aim or throw fireworks at a person, animal, building or vehicle.
- 6) Stay away from a failed firework device for an extended period of time. Never re-light a failed device and always soak it with water before handling.
- 7) When using fireworks use common sense, courtesy, and respect for those around you.

Mayor and City Council filing opens August 24

Election filings for the Mayor's seat and two City Council seats will be accepted at City Hall beginning August 24th. The deadline for filing for these seats is September 7th at 5:00 PM. Interested persons may file for candidacy at City Hall for a fee of \$2.00.

The terms expiring are Mayor Tom Anderson (2-year term); Councilmember Jon Monson (2-year term) and Councilmember Nancy Middleton (4-year term).



Building Permits

Reminder to all residents, building permits are needed for all structural alterations. If you are planning on repairing a roof, deck, or siding of your home, permits are required

before starting such projects. Permit fees will double for those individuals who are found to be working without the appropriate permit. Also, make sure that all permits

have had the required inspections and when doing landscaping projects make sure that you do not bury manholes that are in your yard.

City beaches open for season

Deephaven beaches opened on Saturday, June 5, for the summer. Here is a list of beaches along with specific information about each one.

- St. Louis Bay - lifeguards on-duty from 10:30 am to 8:00 pm.
- Robinson's Bay Beach and Sandy Beach - lifeguards on-duty from 12:00 noon to 6:00 p.m.

Beaches *without lifeguards* include Rocky Beach in Cottagewood and Nocomo Beach in Walden. Residents may use these beaches but do so at their own risk. Both these beaches are open daily from 6:00 a.m. to 10:00 PM.

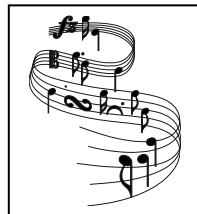
Pedestrian safety

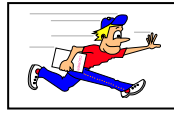
Note to boaters

Mayor's Corner



Does Mutual Aid Really Matter?

Mutual Aid, in this instance, refers to an agreement signed by both South Lake Minnetonka Police and Deephaven Police Dept. and most other law enforcement organizations within the State of Minnesota. Its intent is to ensure that public safety has priority over individual police department interests. Basically, it states that one community may request assistance from another without incurring added cost or legal liability. This agreement is based on the principle that today you help your neighbor and tomorrow they help you. The Agreement is very specific in this way. So why has the leadership of the SLMPD chosen to pick and choose where and when they participate in the agreement? Don't know the answer to that question, but we do know that in the recent case of an arrest that occurred within Deephaven with the assistance of SLMPD that SLMPD leadership has chosen to ignore the Mutual Aid agreement it has signed and pursue legal remedies to get part interest in a forfeited vehicle. Our position as a City is to protect the integrity of the Mutual Aid pact. Shortly after this incident, Deephaven Police assisted in the apprehension of an individual in Shorewood. We returned the forfeited Vehicle to SLMPD. If this agreement is threatened by one party not being willing to accept its principles, then all of our communities will suffer.

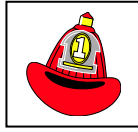
Sullivan Property to be developed

The recently passed Planned Unit Development ordinance will see its first applicant this summer. The property just off of hwy #101, most often referred to as the Sullivan property is currently an industrial site, may be the new home for 28 upscale condominiums. The City is working closely with the residents around the site to ensure that their concerns are addressed. The project includes the annexation of two acres within of the City of Minnetonka property that the City of Minnetonka has agreed to, provided they have input into specific issues relating to landscaping and drainage. Your City is progressing very cautiously given this our first project under the new PUD. There have been attempts in the past to develop multi-family units that were denied do to the lack of City zoning and location. Our community is a single-family community. The PUD clearly defines the area where the City would consider proposals and where it will not consider multi family development. Stay tuned.

Members of the new Excelsior Fire District would welcome the chance to talk to you about becoming a firefighter.

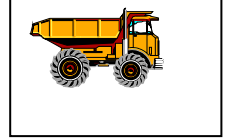

Minnetonka Boulevard Mill & Overlay Project

The City has contracted with Bituminous Roadways, Inc. for a 2" milling and 2" bituminous wearing course overlay on that portion of Minnetonka Blvd extending from the Minnetonka City border in the northeast to Vine Hill Road and extending one block further south on Vine Hill Road to Ridgewood Road.



The project is planned to begin on July 6th with the installation of a culvert underneath Minnetonka Blvd near Thorpe Park and concrete curb work around Chowens Corner. Milling will start after the completion of the culvert and curb work and is estimated to last 4 – 5 days. Paving will follow the mill work and is also estimated to take about 4 – 5 days. It is anticipated that Minnetonka Blvd will remain open during the construction period.

RECYCLING HINTS

NOT EVERYTHING IS ACCEPTED FOR RECYCLING

The materials accepted in the recycling program are wanted by industry as feedstock to make new items. Contamination by unwanted items is a problem. Placing unacceptable materials in your recycling bin is like throwing a bright red towel in with a load of white laundry -- it ruins the whole effect!

The following materials are **NOT** accepted for curbside recycling. Throw these materials into your garbage!

- ❖ All paper milk or juice cartons or boxes
- ❖ All plastic items (bags, toys, tubs, trays, pots, pails, buckets, packaging peanuts, medicine containers, motor oil bottles), except for bottles that come to a neck.
- ❖ Light bulbs, mirrors, window-plate-auto glass, glasses. Plates, bowls, other dishes or cookware, ceramic dishes or bottles
- ❖ Kitchen and bathroom paper products (food wrap, paper towels, tissues, plates, cups, napkins, coffee filters, etc.)



City again earns highest award for financial reporting - Streak hits an impressive 10 years

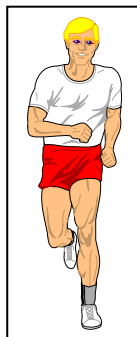
Extending an impressive streak to 10 years in a row, the City of Deephaven has received the Certificate for Excellence in Financial Reporting from the Government Finance Officers Association of the United States and Canada (GFOA). The Certificate of Achievement recognizes and encourages excellence in financial reporting by state and local governments.

The Certificate of Achievement is the highest form of recognition in the area of governmental accounting and financial reporting, and its attainment represents a significant accomplishment by a government and its management.

Deephaven has received the Certification of Achievement each year since first applying in 1994. Sandra Langley, City Clerk/Treasurer and Mary Courtney, Deputy Treasurer/Clerk and Dana Young, City Administrator can be credited with the city's receipt of this award.

Bill Wenmark's 5K Run/Walk & 10K Road Race

The annual walk and run will be held on Saturday, July 10, 2004 at 7:30 a.m. and will begin and end near the Deephaven Elementary School. The course is mostly flat with some wooded areas, but it will be primarily on a portion of the Minnetonka Trail System which has a smooth, gravel surface over a former rail line.



All 5K run/walk and 10K registrants will receive a race t-shirt and an all-you-can-eat pancake breakfast at the Deephaven Elementary School following the race. Non-participants may purchase the breakfast for \$5 per person, which is payable at the breakfast.

Telephone directories may be placed in the paper grocery bag with the other paper products. DO NOT include the plastic delivery bag – either re-use it or throw it into the garbage.

Help keep it from spreading

Garlic mustard (*Alliaria petiolata*) is a highly invasive exotic plant. This biennial herb, also known as Jack-by-the-hedge, invades shaded areas and has a tendency to crowd out other herbaceous species. The Garlic Mustard plant has small black seeds, which form inside a silique. When mature the silique burst forcefully dispersing its seeds. These seeds may travel 6 or more feet and number below a hundred to nearly a thousand. Seed dispersal usually occurs in late spring or early summer and may be human or animal assisted. Water may also play a role in riparian areas, but seeds do not float well. The seeds may be viable for five to six years, though they usually germinate the second year.

Garlic Mustard is very difficult to control. Annual treatment may be necessary until the seed bank is exhausted. Hand pulling can be effective for small populations and can be done most of the year. Remove all cut stems, flowers and seed pods promptly to prevent dispersal. For more information about Garlic Mustard or control measures stop in at City Hall.

Solicitors Require City License

With spring often comes an influx of door-to-door sales and soliciting. Individuals representing organizations that sell products or services require a license from the City. All representatives of the organization must have a copy of the City issued license.

If you have a door-to-door salesperson come to your home, ask to first see a copy of their City of Deephaven license. If they do not have a copy, please do not purchase from them and contact the Deephaven Police Department at 763-525-6210.

If you do not want solicitors coming to your home, post a “No Solicitors” sign by your door. Any complaints about solicitors should be directed to the Police Department.

No Phosphorus Fertilizer Reminder

Metro area residents are prohibited from using phosphorus fertilizers on existing lawns, unless a soil test shows the lack of phosphorus in the lawn. If you are using a non-phosphorus fertilizer, are establishing a new lawn, or have new turf, you do not need to have your soil tested prior to fertilizing.

Lawns in the metro area tend to be very rich in phosphorus, and the extra phosphorus found in lawn fertilizer ends up running off the lawn with water run-off, and into our lakes, streams and wetlands. The end result is a high phosphorus wetland and lots of algae! Not only is this visually unappealing, it is dangerous to wildlife. Because many commercial lawn fertilizers are made by national companies, fertilizers tend to be made for general lawns nationwide, not necessarily providing only what we need for Minnesota lawns. Fertilizers are now available that do not provide the extra, unneeded phosphorus. To find the fertilizer without phosphorus, buy fertilizers with the number “0” as the center number of the three large numbers on the bag of fertilizer.

Personnel at your lawn and garden store will be happy to assist you if you need help with this information.
