

APPENDIX B

STREET NAMES

SECTION 1. Robinson Bay Road. That street in the South 1/2 of the Northwest 1/4, Section 18, Township 117, Range 22 from Northome Road Northerly including private portion.

SECTION 2. Northome Boulevard. That street in the South 1/2 of the Northwest 1/4 of Section 18, Township 117, Range 22 from Minnetonka Boulevard to easterly line of Auditor's Subdivision No. 70, Hennepin County, Minnesota.

SECTION 3. Shavers Lake Drive. That street in the South 1/2 of the Northeast 1/4 of Section 18, Township 117, Range 22 from Maplewood Road east to the City limits, including private portion.

SECTION 4. Deephaven Avenue. That street in the Southwest 1/4 of Section 18 and the Northwest 1/4 of Section 19, Township 117, Range 22 from Park Avenue to Northome Boulevard.

SECTION 5. Montgomerie Avenue. That street in the Southwest 1/4 of Section 118, Township 117, Range 22 from Hamilton Avenue to Montgomerie Avenue.

SECTION 6. Minnetonka Boulevard. That street formerly County Road 5 from the easterly city limits to the Chicago North Western (formerly M and St L) Railroad tracks and from the Chicago North Western Railroad tracks westerly on the northerly side thereof, formerly County Road 82, and following a generally westerly direction to the City limits.

SECTION 7. Thorpe Road. That street in Section 18, Township 117, Range 22 in Thorpe's Country Homes Addition between Hamilton Avenue and Montgomerie Avenue.

SECTION 8. Berry Lane. That street in the South 1/2 of Section 18, Township 117, Range 22 in Boyer's Second Addition, formerly Easton Place.

SECTION 9. Highland Avenue. That street in the South 1/2 of Section 18, Township 117, Range 22 from Therese Street to State Highway 101, formerly Highland Drive.

SECTION 10. Deephaven Avenue. That street in Section 19, Township 117, Range 22 in Deephaven Park Subdivision No. 3, formerly Summit Place.

SECTION 11. Sibley Avenue. That street in Section 19, Township 117, Range 22 in Deephaven Park, formerly Hohenzollern Ave., from Minnetonka Blvd. to Nocomo Ave.

SECTION 12. Ramsey Road. That street in Section 19, Township 117, Range 22 in Deephaven Park, formerly Hancock Street, from Sibley Ave. to the southeasterly line of Lot 574, Deephaven Park, extended.

SECTION 13. Honeysuckle Lane. That street in Section 19, Township 117, Range 22, partly in Deepwood from Minnetonka Blvd. to the cul-de-sac in Deepwood.

SECTION 14. Honeysuckle Road. That street in Section 19, Township 117, Range 22 between Deepwood and Registered Land Survey No. 378 south from Honeysuckle Lane.

SECTION 15. Fairhomes Road. That street in Section 19, Township 117, Range 22 partly in Registered Land Survey No. 68 and Deepwood, south from Fairhomes Lanes.

SECTION 16. Hillcrest Road. That street in Section 19, Township 117, Range 22, partly in East Valley from Minnetonka Blvd. to the cul-de-sac in Outlot 2, East Valley.

SECTION 17. Hillcrest Lane. That street in Section 19, Township 117, Range 22 in East Valley, formerly Hillcrest Road, from Hillcrest Road to the cul-de-sac at Lot 2, Block 1, East Valley.

SECTION 18. Heathcote Road. That street in Section 19, Township 117, Range 22 in Websters First Addition, formerly Holly Road, from Circle Drive to Heathcote Road.

SECTION 19. Ridgewood Road. That street in the southwest 1/4 of the Southwest 1/4 of Section 19, Township 117, Range 22, from Vine Hill Road easterly to the City limits.

SECTION 20. Eastwood Road. That street in Section 19, Township 117, Range 22 from Ridgewood Road southerly to City limits.

SECTION 21. Eastwood Drive. That street in Section 30, Township 117, Range 22 adjoining Wilson's Orchard Addition from Vine Hill Road to Eastwood Circle.

SECTION 22. Cedarhurst. That street in Section 13, Township 117, Range 23, described as Tract Y, Registered Land Survey No. 329.

SECTION 23. Northome Road. That street in Section 13, Township 117, Range 23 in Auditor's Subdivision No. 70, Hennepin County, Minnesota, from Northome Boulevard southerly to the cul-de-sac at Lot 24, Auditor's Subdivision No. 70, Hennepin County, Minnesota.

SECTION 24. Northome Avenue. That street in Deephaven Park between Blocks 8 and 9 from Parkway to Park Avenue.

SECTION 25. North Lane. That street in Section 24, Township 117, Range 23 in Austin's Rearrangement of Part of Summerville from Lakeview Avenue to Summerville Road between lots 4 and 5 of Austin's Rearrangement of Part of Summerville.

SECTION 26. Mount Curve. That street in Section 24, Township 117, Range 23, in Austin's Rearrangement of Part of Summerville from Lakeview Avenue to Summerville Road between Lots 6 and 35 of Austin's Rearrangement.

SECTION 27. Hancock Street. That street in Section 24, Township 117, Range 23 partly in Deephaven Park from Dale Street to Nocomo Avenue.

SECTION 28. Waldon Shores Road. That street in Section 24, Township 117, Range 23, described as Tracts O, P, Q, R, S, T, Registered Land Survey No. 693, lying south of Park Avenue.

SECTION 29. Harper Road. That street in Section 24, Township 117, Range 23, adjoining Cottagewood Shores, formerly alley.

SECTION 30. Cottonwood Lane. That street in Section 24, Township 117, Range 23, in Ideville, formerly Lake Street, north from Linwood Road.

SECTION 31. Linwood Road. That street in Section 23 and 24, Township 117, Range 23, in Revised Cottagewood, formerly Minnetonka Avenue, in part, from Cottagewood Road to City limits.

SECTION 32. Cottagewood Road. That street in Section 23 and 25, Township 117, Range 23 in Revised Cottagewood, formerly Cottagewood Avenue, from Minnetonka Boulevard to Park Place, and from Minnetonka Boulevard to Vine Hill Road.

SECTION 33. Keewaydin Street. That street in Section 23, Township 117, Range 23 in Revised Cottagewood from Lakeview Avenue to Cottagewood Avenue between and parallel to Bay Street and Water Street.

SECTION 34. Manor Road. That street in Section 25, Township 117, Range 23, in Auditor's Subdivision No. 141, Hennepin County, Minnesota, from Cottagewood Road southwesterly to City limits.

SECTION 35. Hooper Lake Road. That street in Section 25, Township 117, Range 23, formerly Lake Avenue, from Excelsior Boulevard to Vine Street.

SECTION 36. Vine Hill Road. That street in Section 24 and 25, Township 117, Range 23, formerly known as County Road No. 5, from State Highway No. 7 to the Chicago North Western (formerly M & St. L) Railroad.

SECTION 37. Excelsior Boulevard. That street in Section 25, Township 117, Range 23, adjoining Forest Hill Farm and Vine Hill Heights, from Vine Hill Road easterly and westerly to the village limits.

SECTION 38. Linwood Lane. That street through Part of Lots 109, 110, 111, 112 and 113, Auditor's Subdivision 141 described as 10 feet either side of a center line described as follows: Commencing at the southeast corner of Section 23, Township 117 North, Range 23 west of the 5th Principal Meridian: thence on an assumed bearing of West, along the south line of said Section 23, a distance of 834.90 feet; thence North 16 degrees and 29 minutes East a distance of 31.00 feet, to the beginning of the centerline to be described; thence North 42 degrees, 11 minutes and 20 seconds West a distance of 244.95 feet; thence northerly, a distance of 43.98 feet, along a tangential curve concave to the east, having a radius of 50.00 feet and a central angle of 50 degrees, 23 minutes and 40 seconds; thence North 8 degrees, 11 minutes and 20 seconds East, tangent to said curve, a distance of 52.22 feet; thence North 37 degrees, 17 minutes and 40 seconds East a distance of 91.11 feet: thence North 37 degrees, 16 minutes and 40 seconds East a

distance of 119.67 feet: thence northeasterly a distance of 70.53 feet, along a tangential curve concave to the southeast having a radius of 84.00 feet and a central angle of 48 degrees, 06 minutes and 40 seconds; thence North 85 degrees, 23 minutes and 20 seconds East, tangent to last said curve, a distance of 125.56 feet and said centerline there terminating. The side lines of this street will be prolonged or shortened to terminate in the west line of Linwood Road as shown on the plat of said Linwood Road.

SECTION 39. Linwood Circle. That street through Part of Lots 102, 109, 114 and 119, Auditor's Subdivision Number 141 described as 12 1/2 feet either side of a center line described as follows: Commencing at the northeast corner of Section 26, Township 117 North, Range 23 West of the 5th Principal Meridian; thence west along the north line of said section, a distance of 958.27 feet; thence northeasterly, deflecting to the right 175 degrees, 49 minutes and 20 seconds, a distance of 126.42 feet, to the point of beginning of said centerline; thence southwesterly, deflecting to the right 180 degrees and 00 minutes, a distance of 126.42 feet, to the north line of said section; thence west along said north line, a distance of 123.03 feet; thence westerly, southwesterly and southerly, a distance of 70.43 feet along a tangential curve concave to the Southeast, having a radius of 44.55 feet and a central angle of 90 degrees, 34 minutes and 35 seconds; thence southerly, tangent to said curve, a distance of 350.00 feet and said centerline there terminating. The side lines of this street will be prolonged or shortened to terminate in the west line of Linwood Road as shown on the plat of said Linwood Road and the northwesterly right-of-way line of the Chicago & North Western Railroad.
