## CHAPTER 6. OTHER OFFENSES

### SECTION 600 CURFEW

600.01 Persons Under 15 Years of Age. It is unlawful for any person under 15 years of age to be on or present in any public street, alley, avenue, park, or other public place, or other unsupervised place in the City between the hours of 10:00 p.m. of any day and 5:00 a.m. of the following day.

Subd. 1. Exceptions. This Section does not apply to a person accompanied by his or her parent, guardian, or other adult having the authorized care and custody of the minor or when the minor person is on an emergency errand or is proceeding directly, without loitering or idling, to or from a school or community function, or business directed by his or her parent, guardian, or other adult having authorized care and custody.

Subd. 2. Prima Facie Evidence. The fact that a person, under 15 years of age, unaccompanied by parent or other adult having authorized care and custody, is found upon or in a public place within the City after 10:00 p.m. and before 5:00 a.m. of the following day is prima facie evidence the person is there unlawfully.

600.02 Persons 15 to 18. It is unlawful for any person 15 years of age or over but under the age of 18 years to loiter, idle, wander, play in or upon any public street, alley, avenue, park or other public place or other unsupervised place in the City between the hours of 12:00 midnight and 5:00 a.m. of the following day.

Subd. 1. Exceptions. This Section does not apply to a person accompanied by his or her parent, guardian, or other adult having authorized care and custody of the minor, or who is engaged in play or organized youth activity under the direction of a school, church, or community organization.

Subd. 2. Prima Facie Evidence. The fact that a person described in this Subsection, unaccompanied by parent or guardian or other adult person having authorized care and custody of the person is found to be loitering, idling, wandering or playing in any such place within the City after 12:00 midnight and before 5:00 a.m. of the following day is prima facie evidence that the person is there unlawfully.

600.03 Businesses.

- (a) It is unlawful for any person operating or in charge of any place of amusement, entertainment or refreshment, or any other place of business, to permit a person under 18 years of age to be on or present in such place of business when prohibited by Section 600.01 or 600.02 of this Code.
- (b) An owner or person in charge or control of any place of amusement, entertainment or refreshment, or any other place of business, who finds persons under 18 years of age on or present in such place of business contrary to Section 600.01 or 600.02, must immediately order the person to leave, and if the person refuses to leave, the owner or person in charge must immediately inform the Police Department.

## **SECTION 605 WEAPONS**

605.01 Definition. The term “weapon” includes: (a) all firearms, including rifles, shotguns and pistols; (b) all bows and arrows, when arrows are pointed tipped; (c) B-B guns, pellet guns and other instruments used to expel pellets of any kind at high velocity, whether by spring, compressed air or gas, or other means; (d) sling shots.

605.02 Possession.

Subd. 1. Carrying Weapons. No person may have any weapon in his possession in any public place in the City unless it is contained in a case and is unloaded in both the barrel and the magazine.

Subd. 2. Motor Vehicles. No person may have any weapon in a motor vehicle unless it is unloaded in both the barrel and the magazine and is contained in a case or carried in the trunk of the vehicle.

Subd. 3. Exceptions. This Section does not apply to peace officers, military personnel while on duty, or persons holding a valid permit issued under the authority of Minnesota Statutes, Sections 624.711 through 624.717.

605.03 Aiming Forbidden. No person may aim a weapon, whether loaded or not, at or toward any person, nor discharge a weapon where there is any person to be endangered, even though no injury actually results.

605.04 Firearm Permit.

Subd. 1. Permit Required. It is unlawful for any person to fire off, discharge or explode any gun, pistol or firearm within the City limits without having in his possession a current and effective permit to do so issued by the Council under Section 455.

605.05 Minors Not to Use Firearms. No person under the age of 18 years may have a weapon in his or her possession or control, except while accompanied by or under the immediate supervision of a parent, guardian or other adult.
