INCIDENT	Reported Date	INCIDENT DETAILS
Damage to Property	2014-05-01	RP reported unknown person damaged two solar lights in their backyard garden. Loss is \$20 dollars.
3rd Degree DWI Arrest	2014-05-02	A vehicle was stopped by an officer after observing poor driving conduct and an equipment violation. After investigation, the driver was placed under arrest for DWI and was transported back to the police department for further testing. The driver

		ultimately submitted to a breath test with a reported result of .12 BAC. The driver was tab charged for 3rd degree DWI and was transported home.
Traffic Stop - Narcotics Citation	2014-05-06	A vehicle was stopped by an officer after equipment and moving violations were observed. After investigation, the driver was found to be in possession of a small amount of marijuana and drug paraphernalia both of which were seized as evidence. The driver was cited for those offenses and released from the scene.
4th Degree DWI Arrest	2014-05-11	A vehicle was stopped by an officer after observing a moving violation and poor driving conduct. After investigation, the driver was placed under arrest for DWI and was transported back to the police department for further testing. The driver submitted to a breath test with a reported result of .15 BAC. The driver was tab charged for 4th degree DWI and careless driving and was released to a sober party.
Traffic Stop - Narcotics Citation	2014-05-10	A vehicle was stopped by an officer after a speeding violation was observed. After investigation, narcotics were located in the vehicle and the driver was subsequently cited for speeding, possession of a small amount of marijuana and possession of drug paraphernalia.
Damage to Property	2014-05-13	Resident called to report someone kicked his mailbox knocking it over. They were able to put the mailbox back up but may need to replace a \$10.00 board. No suspect information available.
Identity Theft	2014-05-13	Resident stopped at the PD to report an ongoing problem with identity theft. An unknown person in Ft. Wayne, IN had changed the addresses on his all his bank accounts to an address in Indiana. Resident and the banks have not suffered any loss at this time. Resident had taken the recommended steps to protect his identity already.
