INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Harassment	2017-09-05	A resident called to report cyber bullying from a past friend. The caller wanted our department aware in case anything happened that the female is viewing her social media accounts and saying mean things about her and her family. She also wanted our department to contact the female and tell her to stop contacting her. An officer spoke to the female and she said she also had texts and emails she could show an officer. The female agreed to not contact the reporting party. The officer informed the reporting party about no contact orders.
Juvenile Problem - Curfew - Citations	2017-09-10	Officer on patrol observed 3 juvenile males riding bikes in the 19900 block of Minnetonka Blvd on the LRT trail. Males were stopped and identified. Parents were notified and juveniles were picked up. Juveniles cited for curfew and citations mailed.
Theft	2017-09-10	A resident reported that a generator and pressure washer were taken from his unattached garage over night.
Domestic/ Disorderly Conduct	2017-09-10	Officers were dispatched to a report of a physical domestic between sisters. Officers arrived on scene and investigated. Parties were separated and went separate ways.
Fraud	2017-09-11	A resident called to report that a check he placed in his mail box had been intercepted and altered before being cashed.
Juvenile Runaway/ Child Protection	2017-09-19	Officer received a radio call to contact a 15 year old male regarding running away from home. Officer spoke with the male and investigated the incident. Child Protection was notified and the male was placed into County Services. Investigation pending.
Juvenile Runaway	2017-09-19	Officer received a phone call regarding a 15 year old male that ran away from home. Officer was familiar with the family and the male. Officer spoke with parent and was advised of the incident.
ID Theft	2017-09-20	An officer responded to a report of fraudulent charges on a credit card. The officer took the information and wrote a report. The officer also told the victim to contact is banks and the credit reporting agencies.
Civil Issue	2017-09-21	An officer responded to a report of check forgery. The victim reported that a former employee cashed fraudulent checks. The officer took the information and wrote a report.

	Burglary	2017-09-21	RP called to report a Barrett .50 semi auto rifle was missing from his residence. RP purchased the weapon second hand and hadn't recorded the serial number. Officer took the information, and gave the RP his case number.
	Loud Party	2017-09-23	Officer was dispatched to a reported loud party at a residence on Hillcrest Rd. Officer located the party and after investigation cited two adults for underage consumption of alcohol. Parties advised and officer cleared.
	4th Degree DWI Arrest	2017-09-25	Officer on patrol observed a vehicle parked in a city parking lot that was occupied by an adult female that was sleeping. Officer investigated the incident and conducted field sobriety on the female. Roxann Marie Winch, 60 of Des Moines IA, was arrested for DWI. Tested .08.
	Theft by Swindle	2017-09-26	RP called to report he had applied for an online loan and was asked to purchase gift cards to repay the loan. RP said he did buy \$600.00 in gift cards then was asked to purchase more cards. RP discovered it was a scam at that point and refused to do any further transactions with that company.
