INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
3rd degree DWI Arrest	2017-01-22	A vehicle was stopped by an officer on patrol after a moving violation was observed. After investigation, the driver Michael Thomas Jamieson , 27 of Chaska was found to be impaired and was placed under arrest for DWI. The vehicle was impounded and the driver was transported back to the police department for further testing. The driver elected to take a breath test with a reported result of .16 BAC. The driver was then booked for 3rd degree DWI, careless driving, and failure to obey a traffic control device and was released to a sober party.

Suspicious Activity - Narcotics Citation	2017-01-01	An officer on patrol located a suspicious vehicle parked in a closed business parking lot and made contact with the vehicle. In making contact with the lone female occupant, the odor of narcotics was detected in the vehicle the party was removed to conduct a vehicle search. After investigation, a small amount of marijuana and drug paraphernalia was located in the vehicle. Both items were seized and the driver was cited for those offenses and released.
Court Order violation	2017-01-04	An officer received a report of a possible Domestic Abuse No Contact Order (DANCO) violation. The officer called the reporting party who was at work out of the city. The alleged violation happened via email on 12/24/16. The officer investigated the case and forwarded it to the City Attorney for review.
Traffic Stop - Paraphernalia - Citation	2017-01-09	An officer on patrol conducted a traffic stop on a vehicle for expired registration. During investigation the officer observed the odor of marijuana in the vehicle, the occupants later handed over several items of paraphernalia with marijuana residue. A juvenile passenger was cited for possession of drug paraphernalia

		and tobacco products. The female driver was given a written warning for the expired registration.
Credit Card Fraud	2017-01-18	An officer received a walk in report of credit card fraud. A resident of Deephaven had her card used fraudulently at a store in Chanhassen. Investigation to ongoing.
Traffic Stop - Narcotics/False Info/Warrant Arrest	2017-01-22	An officer on patrol conducted a traffic stop on a vehicle after a moving violation was observed. After investigation, the driver a 26 year old Burnsville man was placed under arrest for providing false information to police and several outstanding warrants. A passenger was released at the scene and the vehicle was released and legally parked. The driver was then transported to the Hennepin County jail where they were booked for providing false information and the warrants.
